Generally, *California Civil Litigation and Discovery* ("CCLD") focuses on substance; *Litigation by the Numbers*® ("LBTN") on procedure. Some topics are covered in both books, some only in one. Depending upon the length and focus of the course, the instructor may wish to eliminate topics, devote several class sessions to individual topics, or rearrange topics.
